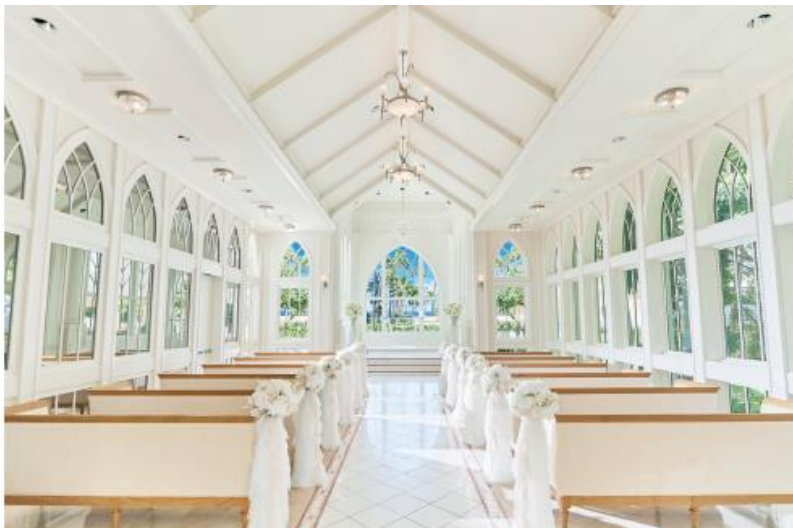

Payment of Fees & Cancellation Policy

Setup Fees

Upon the confirmation of reservation and written acknowledgement by the Company, Customer shall pay \$500 nonrefundable setup fees (“Setup Fees”). The setup Fees shall be applied to the basic package price and also be applied to the deposit mentioned below. *Method of Payment: Major Credit cards such as VISA, MASTER, AMEX, JCB, and DINERS. We will use Square System for this process.

Deposit

Customer must pay a deposit equal to at least 50% of the total fee payable for the basic package (include the Setup Fees) to the Company upon booking. If the payment is not received during the prescribed time frame, the reservation may be cancelled at the Company’s sole discretion without Customer’s consent or further notice to Customer. Payments for the option(s) services purchased by customer will be handled separately.

Final Payment

Payment in full for the wedding package and for all the option services purchased by Customer must be made thirty (30) days before the scheduled wedding day. In the event the balance of the payment is not received within the prescribed time, the reservation may be cancelled, or the Company reserves the right not to provide option(s) services at the Company’s sole discretion without Customer’s consent or further notice to Customer.

Cancellations and Refunds (Wedding Package & Optional Item)

100 % of package and optional fee will be applied if cancelled within thirty (30) days prior to the scheduled wedding date, no refunds shall be made by the Company to Customer.
